<sup>3</sup>The Gas Cost Recovery Rate (GCRR) is reviewed monthly and adjusted to reflect current market pricing for natural gas. The biannual GCRR applies to Residential only and is a 6-month forecast of the monthly adjusted GCRR. This rate is set on August 1<sup>st</sup> and February 1<sup>st</sup> each year and if necessary, subject to interim adjustments.

<sup>4</sup>The federal regulatory charge on fossil fuels collected under the Greenhouse Gas Pollution Act (GGPPA) has been reduced to \$0/GJ by the Federal Government as of April 1, 2025.
